The purpose of these guidelines is not to deter requests for donations, but to better facilitate and manage our community outreach program.

Please read the following information closely and adhere to these guidelines when submitting your request.

## Submission Guidelines

All donation requests must be submitted using our Noble Deeds application during the designated time period and returned as a Word or PDF document to [deeds@nobleperforms.co.uk](mailto:deeds@nobleperforms.co.uk).

## Monetary Requests

Every year, Noble Digital Marketing, Ltd. allocates a set number of hours for service donation requests. Charities with a Charity Registration Number operating in the southwest region of the United Kingdom who wish to receive pro-bono services must complete this application.

## Acceptable Events and Organizations

All southwest United Kingdom charity service donation requests will be open to consideration. All submissions are welcome. # Here's How It Works:


1. All submissions must include a complete application.
2. Complete the application in the provided Word document and send it via email to [deeds@nobleperforms.co.uk](mailto:deeds@nobleperforms.co.uk).
3. The Noble Deeds panel will evaluate the applications received and interview the top submissions.
4. Applications for all requests for services in 2023 must be received by 31 May 2023.
5. The selected entry/entries will be announced on 13 July 2023.
6. Noble Digital Marketing, Ltd will work with the selected recipient(s) to recommend digital marketing services based on the nonprofit's needs and goals, develop a project timeline and determine launch dates.
7. All project work must be completed by 28 February 2024.

## Additional Rules & Restrictions

- To be eligible for a service donation, your not for profit must operate in Bristol and surrounding areas of southwest United Kingdom. Not for profits can have a national presence but must be able to show significant work and impact within the southwest region.
- The recipient must be a certified charity, have a charity registration number and legitimately invest and show proof of finances, i.e. budget, a bank statement.
- Failure to submit your application will result in disqualification.
- Nominees must comply with all terms and conditions of these official rules, and donations are contingent upon fulfilling all requirements.
- The panel's rulings are final.

Nomination constitutes nominees' consent to Noble Digital Marketing, Ltd. and its parent company Noble Studios' use of nominees' names, likeness, voice, opinions, biographical information and residency for promotional purposes in any media without further payment or consideration.
